# **B.** Initial Budgets

# 1. Early Head Start Child Care Partnership – Program 23-168

Office of Early Childhood and Student Services 8/1/23 – 7/31/24

\$613,877

The Commonwealth of Pennsylvania, Office of Child Development and Early Learning (OCDEL) has contracted with the BCIU to partner with two local Child Care Centers to provide Early Head Start services. The Early Head Start Child Care Partnership (EHS-CCP) will provide full-day, full-year services designed to promote the development of young children from birth to three. Early Head Start promotes the school readiness of low-income children (since 2015).

# 2. Early Intervention - IDEA Section 619 - Program 185

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$921,914

This program is federally funded for Early Intervention under the provisions of P.L. 99-457. It supplements Early Intervention services, by funding office rent, property and liability insurance, and other supplemental expenditures. \$485,000 will be funding for Early Childhood Mental Health programs. This program has been in existence since the 1986/1987 fiscal year.

# 3. Early Intervention - IDEA 2004 (Part B) - Component 1- Program 186

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$1,338,037

The federal funding source for this program is P.L. 108-446, Individuals with Disabilities Education Act 2004 – Part B. This budget is Component 1 which supports Early Intervention services such as educational itinerants in addition to supplemental staff expenditures (since 1982/1983).

# 4. Early Intervention - ACCESS - Program 215

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$779,768

Funded by the state, this program, now referred to as the School-Based Access Program (SBAP), is an avenue for the BCIU to receive additional federal funding through Medicaid dollars for medical/mental health-related special education services to students in the PA Medical Assistance Program (since 1991).

# 5. Early Intervention – School Age– Program 300

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$339,784

Mandated by the Department of Education and contracted through a MAWA (Mutually Agreed Upon Written Agreement), this program serves preschool children identified with special education needs who are transitioning to placement in their respective districts. In the year prior to eligibility for school age placement, parents have the option to maintain placement for their child in the Early Intervention Program for an additional year. Educational costs for school age students who remain in the EI Program is the responsibility of the home district (since 1983).

# 6. Early Intervention – Program 348

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$19,144,701

Funded by the state, this program provides services to newly identified preschool children with special needs in Berks County (since 1983).

# 7. Nolde Aides – Program 623

Office of Early Childhood and Student Services 7/1/23 - 6/30/24

\$6,070

This self-supporting enterprise program provides instructional services to teachers and students visiting the Nolde Environmental Center. Classes in group problem solving, content instruction in sciences such as ecology, seasons, wildlife, conservation, and sensory information from nature are offered (since 1975).

# 8. Pennsylvania Inspired Leadership Initiative-Program 152

Office of Professional Learning

7/1/23 - 6/30/24

\$109,000

Funded by the federal government through Appalachia Intermediate Unit, this program supports the development and improvement of leadership skills through the Principals Induction Program (PIP) and the Continuing Professional Education component for all other school administrators. This consortium, which is led by the BCIU, includes Schuylkill, Colonial, and Carbon-Lehigh Intermediate Units (since 2005).

\$387,333

## **Total Proposed Revised Budget: \$6,447,058**

This program consists of funding for the administration and facilitation of OCDEL's Early Head Start-Child Care Partnership (EHS-CCP) Program that serves 324 low-income, at-risk children and their families. The EHS-CCP programs provide funded enrollments and services at the local level, prioritizing partnerships between community-based organizations and local childcare providers. The funding supports contracted professional Nutrition, Health and Mental Health Coaches, and portions of the EHS Manager, EHS Specialist, and other staff positions to administer the grant, along with appropriate travel and supplies. Pennsylvania Key Staff partners with six (6) agencies to provide monitoring, assistance, training and oversight to give full report to OCDEL's Early Head Start Policy Council and Governing Body. These partner agencies receive funding as part of this grant. Each year, we resubmit our plan for this grant, #03HP000326 on behalf of OCDEL. This change is necessary due to increase in expenditures.
